Sawmill Brook—Success!

On December 15, Greenbelt and the Town of West Newbury partnered to successfully protect 32 acres of land next to West Newbury's Mill Pond and Pipestave Hill Conservation Areas. This property is now owned by the Town and will be managed as part of the adjacent conservation areas. In 2024, the Town will grant Greenbelt a Conservation Restriction on the land to satisfy the requirements of the Community Preservation Act. Conserving this land expands the existing trail systems, protects the water quality of Mill Pond, and preserves wildlife habitat, wetlands, and upland forests.
