Completed 22 conservation projects that permanently protected 310 acres. We managed the more than 200 Greenbelt-owned reservations; completed dozens of property improvement projects, and formally monitored 165 conservation easements on 5,170 acres. In addition we held 60 events in 2019, including 35 hikes/walks, Art in the Barn, a Family Nature Series, a Film & Lecture Series, 2 trail runs, 1 bike event, workshops, and a variety of community events with a combined participation of more than 4,000 people. More than 200 volunteers assisted us, and we welcomed over 200 new members and almost 2,000 returning members.
